- 2. Your child will not be admitted without the following items
 - A. Online Registration Completed
 - B. Immunization Record
 - C. Packet Forms (Includes State Form 49444, Food Transportation Form, and Payment Agreement)
 - D. Well Child Certification from Physician (this is just a simple note stating your child is in good health and able to attend Friendship Kids)

- 2. Tuition Rates:

Ten monthly payments will be due the first of every month.

First payment is due by August I, 2016 with the last payment due May I, 2017.

Children must be 3 years of age and potty trained to be eligible for Preschool classes.

Policies For All Classes

I. Registration Policy:

A. A completed registration reserves a child's place at Friendship Kids Preschool and Childcare from the date of registration until 2 weeks after the chosen program begins. If after 2 weeks from the start of the specified program, there has been no communication from the parent, required immunizations or forms have not been received, or the child has not attended any classes or care; the child's reservation will be canceled.

- B. Registration fee is non-refundable
- C. Registration is not guaranteed until processed by the school office.

2. Attendance Policy:

A. Children may only attend the class time in which they are enrolled.

Children will not be allowed to "make up" missed days for any reason, or switch or swap programs or days of care. This includes any days Friendship Kids may close due to weather conditions or any other circumstance.

B. Failure to pay tuition by the 10th of the month will result in a late fee of \$27.00; for bi-monthly payment plans all payments are due on the 1st and 15th of every month. Payments will be considered late if after the 10th or 25th of each month.

*Late Fees are \$27.00 for each late payment and must be paid by the next payment due date. Your second late payment notice will result in a probation period until your bill is reconciled. Your third late payment notice will result in suspension of services from Friendship Kids Preschool and Childcare until the account has been brought current.

- C. No refunds or pro-rating will be given for children who miss Preschool or Childcare for any reason (including but not limited to; illness, vacation or planned absence, suspension due to late payment, suspension due to lack of immunization, or lack of necessary documentation/paperwork)
- D. Any returned checks will have an insufficient funds fee of \$40.00 for each returned check.
- E. To register for any type of rotating schedule, or your childcare needs may vary each week you must notify us at the time of registration and receive written approval before your child is considered "registered" with Friendship Kids.
- F. Friendship Kids cannot guarantee availability outside of your registered childcare plan for any program modification requests. Failure to follow your registered plan will result in additional charges.
- 3. Withdrawal/Termination Policy:
 - A. Parents may withdraw their child from Friendship Kids Preschool and Childcare at any time. Failure to provide written notice 10 working days prior to the desired date of withdrawal will result in billing through the end of the 10 working day period.
 - B. Friendship Kids Preschool and Childcare reserves the right to terminate services for any child at any time.
- 4. Drop off/Pick up Policy:
 - A. It is our goal for your child to be able to walk into the building without help or coaxing from a teacher or parent for our Preschool programs. We understand that some children will need some "encouragement" to stay at preschool at first. You are more than welcome to park your car and walk your child into the building. We do not allow parents to walk their children to class.



- B. Friendship Kids Childcare begins at 6:00am daily.
 - Parents or caregivers are required to walk their child into the classroom, and must sign in daily when dropping off their child. It is the responsibility of the party releasing the child into our care to write in the exact time and sign every time they drop off a student. Parents or caregivers must stay with the child until they are confirmed to be in the care of a Friendship Kids employee. Children may not walk to childcare areas or exit the building unattended after signing in, they must be in the care of an adult at all times. Staff will take any lunch boxes or lunch items at check in, and will place them in the refrigerator.
- C. Friendship Kids Preschool drop off begins at 8:45am and concludes promptly at 9:00am when class begins. Children cannot be in the building without a parent or guardian prior to 8:45am. Any child dropped off before this time will be charged for child care. Parents may enter the parking lot and proceed to the carport facing Northeast with their vehicle. Please proceed in a double line through the carport, and pull all the way forward to the person working the drop-off line. Four vehicles will be allowed at a time under the carport for safety. Parents must put their vehicle in park, when it is safe to leave you will be waved through and the next two cars may pull forward.
- D. Any child arriving for Preschool at 9:00am or after is required to be walked into the building and signed in by a parent or guardian.
- E. Friendship Kids Preschool pick up begins promptly at 11:30am and ends promptly at 11:45am. Vehicles must have their child's security car number clearly visible in the vehicle's front window. NO CHILD WILL BE ALLOWED TO ENTER A VEHICLE THAT DOES NOT HAVE A SECURITY NUMBER. The pick-up line will proceed exactly as the drop-off line, however, parents will be responsible for buckling all children into their seats, due to liability. Please wait to be waved on by the attendant before driving forward, to ensure the safety of all children.
- F. Friendship Kids Childcare closes at 6:00pm daily.

 Parents or the responsible party for the child at pickup is required to sign their child out nightly and must write in the exact pick up time according to Friendship Kids time-keeping devices. Parents or caregivers are responsible for their child while in the building. Children are not permitted to be anywhere in the building without adult supervision.
- G. Any person arriving to pick up a child without a security number must park, ring the Guest Doorbell, come inside the building, provide a government issued picture ID, be listed on the Permission for Pick Up release form. The name listed on the form and ID must match before the child will be released.
- H. No child will be released to anyone not listed on the Permission for Pick Up form. A parent or legal guardian may come in at any time to change the release form in person; NO EXCEPTIONS. In the case a parent has forgotten to amend their release form, the parent will be contacted to pick up their child, and all late fees will apply.

5. Late Pick-Up Policy:

- A. Childcare children not picked up and signed out by 6:00 p.m. will be charged a flat \$15.00 fee until 6:15pm and a \$5.00 per minute fee after that. The \$5.00 per minute fee will be assessed until the child is picked up, no exceptions. Our staff will have an additional care form filled out with the exact time of sign out for you to sign in the event you are late, and the office will send you an invoice for this additional charge.
- B. Preschool students not picked up by 11:45am will be charged a flat \$15.00 fee until 12:00pm and a \$5.00 per minute fee after that. The \$5.00 per minute fee will be assessed until the child is picked up, no exceptions. Our billing office will send you an invoice for this charge.

6. School Closings or Delays

- A. Friendship Kids Preschool and Childcare operates independently of surrounding schools and businesses. Families will be notified of delays or closings by e-mail and broadcast on WTHR-13, WISH TV-8. Be sure to check all postings online as well, as we have seen glitches in the past with information not posting properly to television. Our facility name will appear simply as "Friendship Kids" or "Friendship Kids- Greenwood" on both stations.
- B. There will be no discounts, prorating, or make up days offered for any Friendship Kids closings or delays.



7. Vacation Allowance Policy

Any child enrolled in a Full Time Childcare Program will receive a maximum of one week of vacation allowance for your enrolled program for each child per year (e.g. if you are enrolled in a 3 day/week program you will receive a credit for that amount, not 5 days). Childcare families are eligible for a one week Vacation Allowance between August 2016-August 2017. This week will be discounted from your bill, and is not eligible to be applied separately as single dates not in the same week; the vacation days taken must be within one consecutive week. We must have written notice 30 days prior to your requested vacation to receive the billing adjustment. You can register your Vacation Allowance anytime at friendshipkids.com under the Registration tab.

8. Food Policy:

- A. Parents must clearly note any food allergies on the child's Registration Form.
- B. Parents must also note any dietary restrictions such as Vegan, Vegetarian, Lactose Sensitivity, etc. on the child's Registration Form.
- C. Snacks for all students- A snack will be provided by Friendship Kids to all children under our care mid-morning and midafternoon each day. Parents are allowed to provide their own snack for their child. Parents are allowed to provide birthday treats/party treats from home or the store, but must contact the office prior to doing so.
- D. Parents of children with food allergies will be required to provide a safe snack for their child each day they attend.
- E. Childcare Parents are responsible for providing a lunch for their child daily. Any child that attends Friendship Kids Preschool and Childcare during lunch time and does not have a lunch from their parent will be fed by the school. The child's account will be charged \$8.00 for each emergency lunch provided. This is NOT offered as a daily alternative or convenience, this is only to be used when a parent or relative has forgotten to provide a child's lunch and would be unable bring a lunch to the school in time.
- F. Parents must provide their child's lunch in soft-sided lunch bag. The lunch will be kept in the refrigerator at 41 degrees or below. The bag needs to be clearly labeled on the outside with the child's first and last name.
- G. Children are encouraged to keep a reusable water bottle with them at all times. Water is the only drink that is allowed to stay with the child throughout the day. Toddlers will have milk or other drinks from home offered every 30 minutes or as requested. Children 3-12 years will have hydration offered a minimum of every hour, or as requested.
- H. Friendship Kids Preschool and Childcare will NOT heat, warm, or cook foods for any reason in accordance with State Guidelines.
- 9. Admittance Policy:

Friendship Kids Preschool and Childcare will accept anyone that meets its requirements, and agrees to abide by our policies regardless of race, religion, or creed.

10. Class Placement Policy:

Children will be placed or advanced in Preschool and Childcare classes at the Director's discretion. Children must fully meet requirements to be considered for our Preschool Programs.

- A. 12 months 35 months, or 3yrs and Not Potty Trained
 - I. All children must be at least 12 months of age
 - 2. Parents will be required to provide diapers, wipes, and any other needed supplies diapering.
 - 3. Any diapering or skincare aids such as diaper creams, petroleum jelly, or powders, etc. are considered a medication and must be given to staff upon arrival for safety purposes. Parents must also fill out a Medication Administration Form before any of these types of products can be used. Phone authorization is not accepted.



- 4. It is our policy to change diapers every 90 minutes, or anytime we are aware a diaper is soiled. Diapers MUST be changed anytime a staff member is aware the child is soiled, no exceptions. Dry or clean diapers will be left on.
- 5. Feeding requirements –All foods must be "ready to eat" meaning they are prepared, portioned, and ready for consumption. We will not cut, peel, or portion foods. Foods that staff feels are unsafe will not be fed to children.
- 6. No Bottles allowed, must drink from a "sippee cup" or straw cup. Pacifiers are only allowed at rest time, not throughout the day.
- B. Preschool and Childcare age 3 (3's Preschool Room)
 - I. Age Requirements:
 - A. 3's = 3 yrs old
 - 2. All children must be "Fully Toilet Trained"
 - A. Knows they have to go and will tell a teacher
 - B. Knows where the bathroom is, how to get there, and how to use it without assistance
 - C. Will "hold it" until they reach the bathroom
 - D. Knows how to clean up afterward without assistance
 - E. Can flush the toilet, and wash their hands independently
 - F. Can return to the classroom
- C. Preschool and Childcare Age 4 (4's Preschool Room)
 - I. Age Requirements:
 - A. 4s = 4 yrs old
 - 2. All children must be "Fully Toilet Trained"
 - A. Knows they have to go and will tell a teacher
 - B. Knows where the bathroom is, how to get there, and how to use it without assistance
 - C. Will "hold it" until they reach the bathroom
 - D. Knows how to clean up afterward without assistance
 - E. Can flush the toilet, and wash their hands independently
 - F. Can return to the classroom
- D. Preschool and Childcare Age 5 (5's Preschool Room)
 - I. All children must be "Fully Toilet Trained"
 - A. Knows they have to go and will tell a teacher
 - B. Knows where the bathroom is, how to get there, and how to use it without assistance
 - C. Will "hold it" until they reach the bathroom
 - D. Knows how to clean up afterward without assistance
 - E. Can flush the toilet, and wash their hands independently
 - F. Can return to the classroom
- E. Kindergarten & Grade School Before and After Care (5yrs-12 yrs)
 - I. All children must be "Fully Toilet Trained"
 - A. Knows they have to go and will tell a teacher
 - B. Knows where the bathroom is, how to get there, and how to use it without assistance
 - C. Will "hold it" until they reach the bathroom
 - D. Knows how to clean up afterward without assistance
 - E. Can flush the toilet, and wash their hands independently
 - F. Can return to the classroom
- F. Classroom placement of students will be determined by the administration
- 11. Time of Operation Policy:
 - A. Daily hours: 6:00 a.m. 6:00 p.m. Monday Friday
 - B. Holidays and Closings: See School Calendar



12. Medication Policy:

Friendship Kids Preschool and Childcare will not give any medicinal substance to any child not named on the container, nor will we give medication that is not in its original container. We will not provide any medication, ointments, powders, or any other internally or externally applied treatments. All such items must meet the requirements below. All medication needed will be administered by staff, and recorded on appropriate forms

- A. Medication must come from the parent or legal guardian
- B. Medication must be in its original container
- C. Medication must be labeled:
 - I. Name of child
 - 2. Name of medicine
 - 3. Directions of administration (Time & Dosage)
 - 4. Today's Date
- D. Medication Administration Form has been filled out and signed by parent or guardian.

13. Parent Provisions Policy:

- A. Parents of children enrolled in Friendship Kids Childcare are to provide a small blanket, and/or pillow for daily "Quiet Time." These items are to be taken home each week to be laundered. Items not taken home by close on Friday will be placed in the lost & found. Parents are responsible for checking the Lost and Found for any missing items. Lost and Found will be taken to Goodwill each quarter.
- B. Parents must provide updated information whenever there is a change in names, addresses, phone numbers, emergency contact information, etc.
- C. Parents must provide a complete change of seasonally appropriate clothing for their child, including shoes. The change of clothing should be placed in a sealed clear plastic bag with the child's name clearly labeled. **All** articles of clothing should be labeled, and kept in the child's back pack daily.
- D. Children should come to school dressed in seasonally appropriate clothing. If weather permits, and as determined by the director, children will go out doors daily. Therefore all students should come with a coat, hat, gloves and any other winter attire you would want them to wear during cold weather, and also rain boots and rain coats for rainy days. Because we consider the outdoors an extension of our classroom, we will be using certain weather events as learning opportunities. So be sure that your child is dressed comfortably every day for weather conditions.
- E. Electronics from home are prohibited. Due to increased risk the only technology used by the children will be games or property of Friendship Kids only. This way we can ensure the safety of the content your child is playing or viewing. We may restrict any child from using any electronics at our discretion.

14. Field Trip Policy:

- A. Parents must sign permission forms for your child to attend any Friendship Kids off campus field trips. Please be aware a small fee may accompany some activities. We rely on parents, guardians or relatives of children registered with Friendship Kids for transportation to some events. You are responsible for providing a booster seat for each child attending that meets all State and Federal requirements for age, weight, and height. If you are not comfortable with your child being transported in any of these ways you are welcome to provide transportation for your child, or you may choose to keep your child home.
- B. If your child is registered for childcare, you are not required to attend any off campus field trips. Permission for transportation will be required for Friendship Kids Preschool and Childcare or their affiliates to transport your child in



- any way. If you are not comfortable with your child being transported in any of these ways you are welcome to provide transportation for your child, or you may choose to keep your child home.
- C. If your child is 3 years of age or older we will not offer "opt out" care at the facility, or discounts if your child is not in attendance for off campus functions. "Opt out" care is only provided for I and 2 year old children.
- D. Parents of our I and 2 year old children are welcome to attend any Friendship Kids off campus field trip with their child, or their child will remain at Friendship Kids for care. We do no transport children under the age of 3 years.

15. Outdoor Policy:

- A. Children will go outside daily, weather permitting, for play, games and exercise. When this is not possible, children will have "playground time" indoors.
- B. Children must come prepared for the season (i.e. winter time coats, hats, snow pants, mittens, and boots/ summer time- bathing suits, towels, and water shoes). Please label all articles of clothing with your child's name.

- G. Begins to grip crayons and pencils appropriately with 3-4 finger grip
- 4. 4's
- A. Know all K-3 material
- B. Know letters and sounds
- C. Know name and value of numbers 1-20
- D. Write own name recognizably
- E. Write all the letters
- 5. 5's
- A. Know all the K-3 and K-4 material
- B. Know, independently identify, and write all letters
- C. identify multiple vowel sounds
- D. Know the name, order and value of numbers 1-100
- E. Begin blending and sounding out small words

17. Parental Agreement Policy:

A. Illness:

- 1. Parents must notify Friendship Kids Preschool and Childcare of any illness. Parents are required to make arrangements to have their child cared for outside the center if the child is contagious, has a fever, nausea or vomiting, has diarrhea, discharge of the eyes, discolored nasal secretion (yellow, green, brown) or excessive runny nose, has persistent cough, or is otherwise obviously ill as determined by the Director or Staff.
- 2. Parents must pick up their child within I hour of notification of their child becoming ill.
- 3. Children must be free of a fever, vomiting and/or diarrhea for at least 24 hours. If your child has seen a doctor for any illness, you must provide a release stating when your child can return for services. We trust our parents to help us protect all children at Friendship Kids from the spread of any contagious disease, viruses, or colds.
- 4. Head Lice- If your child has or has possibly come in contact with head lice, you are required to notify us immediately! To prevent the spread of lice, we have a no-nit policy. Your child must have received treatment for head lice, and must be nit-free before they will be accepted back to school. An examination by the Director or a staff member must be performed before the child will be re-admitted.
- 5. Parents agree to absolve Friendship Kids Preschool and Childcare of any and all financial responsibility due to any illness and/or injury incurred by the child while at the center.
- B. Administrative decisions: Parents agree to abide by the decisions made by the Director regarding their child's care while attending Friendship Kids Preschool and Childcare.
- 18. Health Policy:
 - A. Keep your child home if he/she is/has: (Children will not be admitted for services or will be sent home if the following is observed by any staff member.)
 - 1. Temperature of 100 degrees or more in the last 24 hours.
 - 2. Conjunctivitis (Pink Eye or discharge from eyes), bronchitis or impetigo
 - 3. Rash of any kind. (A physician's note that the rash is not contagious is the only exception)
 - 4. Diarrhea and/or vomiting within the last 24 hours
 - 5. Severe cold with fever and/or drainage
 - 6. Nasal drainage that is discolored (yellow, green, brown)



- 7. Any contagious disease or condition (lice, scabies, scarlet fever, measles, chicken pox, mumps, etc.)
- 8. Is on medication for a contagious illness. Your child cannot attend unless he/she has been on such a medication for at least 24 hours and is fever and/or symptom free

B. Reporting an Illness:

Parents must report any and all illnesses by calling 317-535-2544. If you reach our answering service please leave a message with the child's name and condition you are reporting, as well as dates the child will not be attending their scheduled program. This allows us to notify parents in a timely fashion of any contagious illnesses.

C. Sun Safety:

- 1. Children should arrive for care with sunscreen pre-applied daily.
- 2. Friendship Kids will provide sunscreen throughout the day for all childcare children. If your child has a skin sensitivity or allergy, you must list it on your Registration Form, and also provide sunscreen for your child.
- 3. Children are encouraged to wear a hat and sun glasses for all outdoor activities.
- 4. Long sleeve pants and shirts are encouraged to help protect your child from the damaging effects of the sun.

D. Hand Sanitizer

Hand sanitizer labeled "Keep out of reach of Children" will not be allowed. However, we do have sanitizer available in every classroom, and is dispensed by an adult. Any sanitizer found in backpacks will be confiscated and thrown away.

19. Biting

A. Biting is an age appropriate developmental issue that is not uncommon among toddlers (12-35months). Friendship Kids provides appropriate supervision at all times to children, but preventing biting 100% of the time in this age group is virtually impossible. Please be confident in knowing that biting normally goes away with time.

B. Purpose of The Biting Policy

This policy is written to enhance children's safety by summarizing why children bite, actions taken if a child is bitten, describe techniques used by our staff to prevent biting incidents, and to outline what will be done if a biting incident occurs.

C. Reasons Children Bite

- I. Children learn by exploration and toddlers are "oral beings;" thus, they will place everything into their mouths, which may include another child's finger or body.
- 2. Children bite to relieve the pressure resulting from new teeth breaking through the gums.
- 3. Toddlers do not have cognitive (thinking) ability to discriminate between animate (live) and inanimate (not live) objects. This means that the child may not be able to distinguish between a teething ring and another child's plump arm.
- 4. Biting is a basic response to frustration, hunger, or being tired because toddlers and two year olds do not have the vocabulary to articulate these feelings/emotions and due to limited social skills.
- 5. Toddlers bite in order to move children who are in close proximity, too rough, or too intimidating.
- 6. Children bite to get attention whether negative attention versus no attention at all.
- 7. Children bite to protect personal space because they need a certain amount of space around them and do not want intrusion.

D. Preventative Steps

- I. A major preventive step is to keep group sizes as low as possible, and keeping our attention focused on the children.
- 2. Keeping appropriate toys available in which children may bite such as teethers and rattles.
- 3. Teach children alternative methods to express their emotions/feelings (feeling faces, giving emotions names like happy and sad, etc.)
- 4. Attach teether to child's clothing, in a safe manner.
- 5. Remind child to bite teether when frustrated and not another child.

E. Employee Protocol If Biting Occurs:

- I. Do focus attention on the bitten child and remain calm and not overreact. Be prepared to quickly intervene to stop the biting with a firm statement such as, "No...we do not bite people!"
- 2. Do assess the bitten area, and clean with soap and water. Apply bandage if the bite breaks the skin.



- 3. Do apply an ice pack to bitten area for 15 minutes then reassess area; repeat as needed for comfort or swelling.
- 4. Do assess bitten area of the child for signs of infection over the next few days (warmth, reddened area, pain), document any observations, and report changes to the Director. The Director or lead teacher will notify the parent by phone, and recommend the child be taken to a healthcare provider if necessary.
- 5. Do allow the biter to gently stroke or hug the child who was bitten to promote appropriate social behavior.
- 6. Do recommend to the parent to consult a healthcare provider if the bitten area has broken the skin or is in a prominent place such as the cheek or face.
- 7. Do educate the child that biting causes pain and sadness for the other child.
- 8. Do teach children how to love each other and interact with one another in a positive way.
- 9. Do give the child appropriate activities (sensory activities) to help cope with the biting.
- 10. Do monitor the "biter" in an effort to redirect him/her as needed.
- 11. Do document the incident, notify the Director, and call parents to notify them of the situation.

F. Suspension and Dismissal

Our heart is to minister to every child and family we provide care for, and to help them through this process while maintaining the highest level of safety for all children in our care at all times. Every situation is different, and we will make any suspension or dismissal determinations on a case by case basis. All decisions will be made by the Director.

20. Discipline Process:

A. Friendship Kids Preschool and Childcare realizes that children need to learn self-discipline, and they need to develop their social and behavioral skills so they can function in group settings. We also realize that the consistent standards taught in the Bible are the best, and most easily applied set of lifestyle regulations ever assembled.

Because He created us, God knows what is best for us

- B. Scripture states that people are the happiest; their self-esteem is the greatest, when they know what the limits are. The limits that form the boundaries of our existence are set by God and are based on the standard of His character. (He never changes, He never lies, and He always directs us toward what is best). Anyone who will choose to live according to His standard will be content, happy and full of joy. (Joshua 1:8, Psalm 1:1-3, Prov. 29:18, Matt. 7:24, Luke 11:28, John 8:30,32,14:6, Romans 8:28, Philippians 4:9, James 1:25, 4:17, Rev. 22:14)
- C. There is a difference between discipline and punishment.

 Punishment is an act, Discipline is a process.
- D. Discipline is a method whereby a person is taught the rules that bound a certain situation or activity. Discipline's goal is to get a person to think about their DECISIONS which form their DIRECTION, which fixes their DESTINY.
 - 1. Instruct: A person must know what is expected and what is and is not acceptable behavior
 - 2. Repeat and Redirect: Restate the rule and show how to follow it
 - 3. Admonish: Comes after the rules have been broken on multiple occasions. An individual must know what he/she has done is not acceptable, that it has negative affect on others. Admonition is simply clearly communicating that the behavior is inappropriate in a "one-on-one" setting so that the child fully understands. It is a time of personalized instruction that uses the child's actions and choices as examples of right and wrong behavior.

E. Disciplinary Action:

Our Philosophy of Disciplinary Action:

Even though the Bible teaches that spanking may be necessary, it is to be administered by the parent, and does not advocate spanking as the only, or even the first means of correcting behavior. (Proverbs 22:15, 22:13-14, 29:15). The Bible teaches that parents are ultimately accountable for the manner by which they raise their children. Therefore, the bulk of the responsibility and burden of discipline should come from them.(Deuteronomy 6:3-9, 11:19-21, Proverbs 4:1-4, 19:18, 26:6, 29:17, Matthew 12:36, 18:23, Luke 16:2, Romans 14:12, Hebrews 13:17, Ephesians 6:4). Because parents differ in their concept of the way, the reason, and the method of disciplinary action *Friendship Kids Preschool and Childcare* will adhere to the following:



- 1. The staff of Friendship Kids Preschool and Childcare will NOT:
 - A. Use corporal punishment/spanking in any form
 - B. Berate or humiliate a child verbally
 - C. Seclude a child for disciplinary purposes
- 2. The staff of Friendship Kids Preschool and Childcare may:
 - A. Use "Time Out" as its ultimate form of discipline. Once a child has progressed through repetition, redirection, and admonition, further misbehavior will cause:
 - B. Removal of the child from the activity area/group for a period of time using the "Time Out" or "Time In Method.
 - I. "Time Out" last up to I minute per age of child (i.e. A 3 yr old will spend no more than 3 minutes in "Time Out").
 - 2. "Time In" means the child will spend some time helping the teacher with a task to help rectify the situation. (Example: If child used their hands to rip a book, the child will spend their time in organizing the books.)
 - C. Use additional redirection and loss of one or more privileges.
 - D. Send the child to the Director's office, or Pastor if the Director is unavailable for further redirection of misbehavior.
 - E. Notify parents if the child has received "Time Out" frequently during the course of the day and further discussion is needed. We will partner with parents to use loss of privileges at home, and the use of actions relating to consequences to help children understand that all behavior has a consistent consequence. For example, good choices mean good consequences; bad choices mean bad consequences.
 - F. Call a parent/teacher conference to discuss repeated behavioral issues or any concerns regarding their child. The Director will implement a Behavior Modification Plan for staff and parents to follow consistently with their child to achieve healthy behaviors and results. Part of this process may be having a certified behavior therapist observe your child's classroom to evaluate all aspects of their environment that may assist us in best helping your child.
 - G. Call parents to come to Friendship, discipline their child, and return the child to their classroom if all of the above have been ineffective or the Pastor or Director deem it necessary based on the severity of the infraction. If this is the case, it will be our recommendation that the child remain in our care so that misbehavior is not seen as a reward for the attention of, or time with the parent.
 - H. Parents may be required to pick their child up from care if that child has cause emotional or physical harm to any person, (teacher, student or other) and/or leaves any physical mark on the body of another person at the discretion of the Director. Parents are required to pick up their child within I hour of receiving notification that their child requires a parent's presence at the facility. Failure to pick up your child within the hour may result in immediate dismissal. That child may be suspended for the remainder of the day, or at the discretion of the Director. Friendship Kids will not offer prorating or discounts for any days your child is suspended due to behavior.
 - I. In the event a child becomes a threat to the safety of themselves, another student, or staff member; that child will be restrained by a trained staff member until a parent can pick them up. Examples of threatening behavior include, but are not limited to; hitting, kicking, biting, spitting, pinching, threatening harm or using hurtful words, running from staff or attempting to run out of the classroom or building, or throwing objects. In this case, a child is then considered a danger to themselves and/or others. In such a situation, it may be determined by the Director that we are unable to safely care for your child. If these behaviors persist or parents/legal guardians are unwilling to follow recommendations made by the Director for the safety and wellbeing of the child, termination of services will be effective upon the preschool's notification to the parent/legal guardian. This of course is an absolute last resort.
- 21. Transportation Policy

If a student is suspended or expelled from the bus by the Clark Pleasant School Corporation or by our contracted transportation provider, Friendship Kids offers no additional transportation options. Parents are responsible for their child's transportation to and from school and any activities or field trip destinations.



22. Social Media and Personal Contact Policy

It is the policy of Friendship Kids Preschool and Childcare that any information regarding students, care, or concerns of any nature are strictly prohibited from being discussed through social media. We do not restrict our employees from engaging in Social Media with parents or relatives of students as long as there is a clear boundary understood that no Friendship Kids business will be discussed using these forums. Failure to follow this policy or the solicitation of information regarding a Friendship Kids Preschool and Childcare student or staff member may result in immediate dismissal. This also includes but is not limited to obtaining personal phone numbers of employees without the permission of the employee or the Director, or using an unauthorized source of contact outside of business hours to discuss Friendship Kids business. You may contact us at the phone numbers and email addresses below, and be sure to leave a detailed message including your name, name of the child, the date, time, and purpose for your call. We do our best to respond within 24 hours to all calls or emails, or the next business day if received after office hours, on weekends, or during a holiday.

23. Media Policy

Throughout the year Friendship Kids takes photos of children and staff to use for crafts and other special event presentations. We also enjoy showing our day to day activities through our website and other social media pages.

24. Keyless Entry

This system is another safety feature we have added to secure the front entrance of our building at all times. The building will remain locked during business hours from 6am-6pm Monday-Friday. To enter the building parents will be given a 4-digit code to enter on the key pad.

This code is NOT to be given to any person other than the parent or legal guardian of a child in our care. Relatives and other persons authorized to pick up your child from care will need to ring the "Guest Doorbell" and an employee will come to the front door to assist them. If for any reason you do not receive a response after ringing the doorbell, please call 317-535-2544 for further assistance.

Abuse or the sharing of any security code with an unauthorized person will result in immediate dismissal from services, or suspension from using our keyless entry. If you lose your keyless entry privileges, you will be required to ring the "guest doorbell" for your entry needs.

PLEASE do not hold the door open for anyone other than your own family. Each family has their own code to enter the building, and this keeps your children safe from anyone entering that does not, or should not, have a code to the facility.

ALL visitors/parents/guardians must use the front door entry and exit.



25. Payment Options for Preschool and Childcare

Preschool

Based on a 10 month school year (August -May) *See calendar for holidays and vacations.

Ten monthly payments will be due the first of every month.

First payment is due by August 1, 2016 with the last payment due May 1, 2017.

Child Care

Child Care is a year around program.

You may either pay the 1st of every month, or on the 1st and 15th of every month.

Any requests for payment plan changes or adjustments must be approved by the Director. Requests for changes must be made in writing, and require a sit-down appointment to sign new documents.

26. Records and/or Forms Requests

A parent, guardian, or third party must submit a Friendship Kids Records Request form for any documentation or forms requiring information of any kind regarding students, attendance, or financial records. Requests of this nature may be listed as, but not limited to; attendance records, certified statements from a teacher or caregiver for medical or legal purposes, or the completion of any legal forms. Once the Friendship Kids Records Request form has been received by the office staff, the request must be approved by the Director in order to be processed. Please allow a minimum of 14 days to process your request. There will be a flat \$7.00 fee per request, and a charge of \$1.00 per one-sided page for copies of records. For security reasons, records will not be faxed or emailed. Records will not be released until all fees are paid in full, no exceptions.

27. Friendship Kids T-Shirts

Friendship Kids T-Shirts are given to all students who pay a Registration Fee. Each child is given one T-Shirt. If your T-Shirt is lost or ruined you may purchase an additional Friendship Kids T-Shirt for \$8.00. Friendship Kids T-Shirts must be worn on all Friendship Kids outings for security reasons.

28. Parent Resources
